# AGENDA ITEM NO. 5 – 2021 – 2022 COVID TRANSITIONAL SUPPORT FUNDS (SHS DIRECTOR)

SHS Director noted in her Briefing Note that she requires Chief and Council authorization to accept \$5,891.00 in COVID-19 Transitional Support Funding (Ontario Works Program).

The Ontario Works Department has received ongoing requests for assistance as it pertains to the aforementioned supports available through this funding

### AGENDA ITEM NO. 6 - COMMUNITY DONATIONS (CJ)

Councillor CJ noted in her Briefing Note that an initial request to see if Mississaugas of the Credit would accept a donation of moose meat from the fall harvest of 2021. Moose was harvested in Northern Ontario within the Wiikwemkoong Unceded Territory / Robinson Huron Treaty area, namely the Spanish Forest area.

The question was raised to Chief and Council, if MCFN has ever taken on wild game donations and/or is there a process currently in place to accept such donations. There was not any prior formal process of how MCFN accepts donations such as these.

The harvest time of moose season is nearing its end and the opportunity for donation of whole moose harvest has passed. There was also a second transfer of moose meat which was directly purchased from one family, and again this will be by the choice of that family how it wants to be used in storage or distribution.

# AGENDA ITEM NO. 7 – McMASTER VISION SCREENING (EXECUTIVE DIRECTOR OF OPERATIONS)

Executive Director of Operations noted in her Briefing Note that she is requesting approval for McMaster Children's Hospital to collaborate with the Community Health Program to provide the Indigenous Children Eye Examination Program (ICEE).

Meetings have been held with Dr. Yasmin Jindani and Dr. Srabi from McMaster Children's Hospital on a project called Indigenous Children Eye Examination Program. The program is offering three separate vision/screening tests to MCFN children under the age of 16 years. A passive consent process is being proposed i.e a letter being provided with information on the program, and if a parent wishes to opt out, a note can be sent back that they do not wish their child to participate. The vision/screening test is not a full eye exam.

November 24 – 26, 2021 is being considered for the screening. The ICEE is requesting permission to send the letters through LSK and ECC notifying parents of the program and permission to proceed with the passive screening process. And further, Executive Director of Operations is recommending that the Community Centre rental fees be waived for this important initiative.
