**AGENDA ITEM NO. 5 – MOCCASIN IDENTIFIER – AMENDMENT FOR THE GREENBELT FOUNDATION AGREEMENT (CULTURE & EVENTS COORDINATOR)**

Culture and Events Coordinator noted in her Briefing Note that she is seeking approval to accept the amendment to the current grant agreement with the Greenbelt Foundation

Moccasin Identifier submitted a proposal to one (1) of our current funders; the Greenbelt Foundation seeking additional funds of fifty thousand dollars (\$50,000) for development of a communications plan and interactive online mapping resource.

This funding request was approved by the Greenbelt Foundation. The additional funds will be allocated to Professional Services 56500-100507. Funds are to be spent by March 31, 2023.

## **AGENDA ITEM NO. 6 – NIAGARA REINFORCEMENT LINE (NRL) (EF)**

Councillor EF noted in her Briefing Note that MCFN Chief and Council purchased 20% equity in Hydro One's Niagara Reinforcement Line (NRL) in 2019.

The revenue earned on the NRL is paid directly to Peace Hills Trust who is the Trustee for the investment.

Jeffrey Smith/Managing Hydro One Indigenous Partnerships Inc., conducts quarterly meetings with two members of the MCFN Council, and provides financial updates to all the investors via email.

Attached are the financial reports for July 2022, on the Niagara Reinforcement Line revenue, received from Jeffrey Smith/Hydro One via email. July's report was received on August 19, 2022.

The revenue generated on the Niagara Reinforcement Line for the Mississaugas of the Credit First Nation (MCFN), is higher than originally projected.

Jeffrey has explained in his two emails the hot summer has contributed to the revenue earned on the NRL.

#### **AGENDA ITEM NO. 10 – HALDIMAND/NORFOLK CANADA-WIDE EARLY LEARNING AND CHILD CARE SYSTEM (DIRECTOR OF LIFELONG LEARNING)**

As a side note, Early Years Administrator (Katharine Brown) informed that she was unable to do anything on September 30<sup>th</sup> as she does not have the capacity to do it.

Director of Lifelong Learning noted in her Briefing Note that she is seeking Chief and Council to approve opting in to the Haldimand-Norfolk Canada-Wide Early Learning and Child Care System (CWELCC) for the Maawdoo Maajaamin Child Care Centre.

In March, 2022, Ontario signed a historic deal with the federal government that will lower licensed child care fees to an average of \$10 a day by September, 2025. As a first step, families will see an average 25 percent reduction in their fees retroactive to April 1, 2022 which will be further reduced to 50 percent by the end of December, 2022.

Under an agreement with the federal government, Ontario will receive \$13.2 billion over six years which Ontario will use over five years, to reduce fees for families and deliver an average of \$10 a day child care for eligible children by September, 2025.

Councillor EF noted that the budget never came to Chief and Council. Early Years Administrator answered that she has a preliminary budget. She stated that opting in is the first

step, and then the budget comes to Chief and Council. She also noted that we can opt out anytime. The opt-in deadline is November 30, 2022.
