**AGENDA ITEM NO. 7 – MOTION TO BE READ INTO MINUTES – MOHAWK COLLEGE LETTER OF SUPPORT (THIS MOTION WAS APPROVED VIA EMAIL)**

Director of Lifelong Learning noted in her Briefing Note that she is seeking Chief and Council to approve of the partnership with Mohawk College, and further, to sign the letter of support along with providing administrative support to facilitate their request for applying for a funding grant.

Mohawk College is in the process of applying for a funding grant offered jointly by the Social Sciences and Humanities Research Council (SSHRC) and the National Centre for Truth and Reconciliation (NCTR). The Reconciliation Network in Response to Call to Action 65 funding grant will provide between \$7,000.00 (Seven Thousand Dollars and Zero Cents) and \$1 million annually over 5 years.

MCFN has a long-standing relationship with Mohawk College with MCFN Community Members attending at both the Hamilton and Brantford campuses over the years.

To partner with Mohawk College, the College needs a letter of support and for MCFN profile and partner details to be completed on the Social Sciences and Humanities Research Council portal site. The total in-kind contributions for this partnership is \$6,195.00 (Six Thousand One Hundred and Ninety-Five Dollars and Zero Cents).

Councillor EF questioned if we could have applied for this grant ourselves.

**AGENDA ITEM NO. 6 – PRESENTATION BY CONESTOGA COLLEGE REGARDING  
APPROVAL OF CONESTOGA'S PROJECT & FUNDING/RESOURCE REQUEST  
(DIRECTOR OF LIFELONG LEARNING)**

Director of Lifelong Learning noted in her Briefing Note that she is seeking approval of the project details and funding being sought by Conestoga College.

Conestoga College is in the process of applying for a funding grant offered jointly by the Social Sciences and Humanities Research Council (SSHRC) and the National Centre for Truth and Reconciliation (NCTR). The funding grant will provide up to \$1 Million annually over 5 years (\$200,000 annually).

Conestoga will present to Chief and Council at the Intergovernmental Relations Council on May 9, 2023 (attached as Appendix A) and will seek approval of Conestoga's Project and Funding/Resource sharing request. The full award for this funding is \$200,000.00 (Two Hundred Thousand Dollars and Zero Cents) per annum to a maximum of \$1,000,000.00 (One Million Dollars and Zero Cents) over five years. Upon successfully receiving this award, funds will be shared directly with MCFN to hire a Language Teacher and Highly Qualified Personnel.

Funds will be also be used to pay for the delivery of Language Nest Programming in the Community, Research Lead salary, and Research Assistant salary. There will be an in-kind donation of a Program Manager and Training Specialist from Conestoga.

Danielle Boissoneau from Conestoga College reiterated most of what the Director of Lifelong Learning wrote above. She is the Director of Initiatives at Conestoga College.

- Creating partnerships with School of Creative Industries to design, develop and deliver Anishinaabemowin Teaching and Learning Certificate Program.

The funding grant will provide up to \$1 Million dollars over 5 years (\$200,000 annually).
